The sequence of Admission Activities: The candidates, on arrival at FBS, must collect Admission Form and Bank's Deposit Slip for admission fee payment. They must bring the following original documents along with them:

- Certificate and Transcript of S.S.C/O Level examination
- Certificate and Transcript of H.S.C/A Level examination
- Certificate and Transcript of Bachelor and/Master's Degree
- Migration Certificate. (From the previous institute)
- Freedom Fighter/Special Quota Certificate from the appropriate authority (If applicable)
- Two copies of passport size colored photographs duly attested.

The candidates will then report to BUP Medical Centre located inside the campus; handover in the following medical documents collected from any reputed hospital/clinic, and collect a medical fitness certificate:

- Blood group
- Urine R/E
- HBs Ag

The serving military officers shall have to deposit Taka 35,100 (Tk. Thirty-five thousand and one hundred only) and other candidates declared medically fit shall have to deposit Taka 58,500 (Tk. Fifty-eight thousand and five hundred only) in favor of "**Dean, FBS, BUP**" A/C number **0028-0310036572**. They must collect the money deposit slip from MBA (Professional) Program Office, AC-301. Candidates may make their deposits at the Trust Bank Booth located at Mirpur Cantonment or at any other branch. They should obtain the bank receipt as they will be required to deposit it in order to complete admission processes.

Finally, candidates are required to report to the MBA (Professional) Program Office and deposit the necessary documents to complete the admissions process:

- Completed Admission Form
- Money deposit slip/receipt of the bank
- All original certificates/documents as mentioned in the above paragraph

Commencement of Academic Session: Academic session will commence on 12 May 2022. The inauguration ceremony and students' orientation program will be held on the same day at 5.00 PM. Relevant information will be given at the inauguration ceremony. The detailed information on academic curriculum and administration will be available on the BUP website by 10 May 2022.
